



## Dynamo Swim School - Policies & Release

Effective January 1, 2010

**Please read and sign the following. Please initial each paragraph.**

\_\_\_\_\_ **Class Minimums:** A minimum number of students is required in order for Dynamo Swim School to hold a class. Class minimums are as follows: DynaBabies/ Adults - 3; Preschool/ Gradeschool - 2. In the event that Dynamo Swim School cancels a class due to low registration, the staff will work with you to find an alternative class in the current or upcoming session. If no appropriate alternative is available, Dynamo Swim School will issue a credit for the entire registration amount.

\_\_\_\_\_ **Refund Policy:** NO REFUNDS. We hire and schedule instructors based upon registration numbers.

\_\_\_\_\_ **Make Up Policy:** We do not offer make up classes for any reason.

\_\_\_\_\_ **Cancellation Policy:** If you withdraw from a class, you will not receive a refund. You will receive a Dynamo Swim School credit for the classes withdrawn from less a \$25 cancellation fee.

\_\_\_\_\_ **Schedule Change:** Schedule changes are subject to class/session availability. Each schedule change is subject to a \$25 schedule change fee.

\_\_\_\_\_ **Illness Policy:** If your child is absent from class due to illness, a credit will be issued when a note from the doctor is presented. The note must have the dates that the child was not allowed to participate in class. No credit is issued without a note from the doctor.

\_\_\_\_\_ **Credit Policy:** Credits are issued only for an illness with a doctor's note or pool closures. Credits are not issued for conflicts with other activities or vacations.

\_\_\_\_\_ **Inclement Weather:** With the exception of our Summer Satellite Program, all Dynamo Swim School lessons are held at indoor facilities. Therefore, cancellations due to weather are infrequent. It is our policy that if all schools are closed in the county for inclement weather, then Dynamo Swim School is closed and we will issue a credit.

\_\_\_\_\_ **Credits:** Dynamo Swim School credits may be applied toward future swim lessons - group or private. They may also be used toward other non-competitive programs (i.e. recreational swim, aerobics) at a Dynamo Swim Club facility. Dynamo Swim School credits may not be applied towards Dynamo Juniors or swim team dues unless that child is moving from the swim school to that program. Credit slips must be presented in order to be redeemed. Credits will not be replaced if lost or stolen. Credits are not redeemable for cash.

\_\_\_\_\_ **Swim Diapers:** All students under the age of four (4) years are required to wear a reusable swim diaper with tight fitting elastic waist and legs. Disposable swim diapers are not allowed. No exceptions. Students under the age of 4 without a swim diaper will not be allowed to participate in class.

\_\_\_\_\_ **Pool Closings:** Dynamo closes its pools for the following reasons: (1) When a child vomits or has a bowel movement in the pool; (2) Inclement weather; (3) If conditions in the pool make it unsafe for students to be in the pool. When the pool is closed for any of the above reasons, a credit will be issued.

\_\_\_\_\_ **Pool Closing Fee:** If your child vomits or has a bowel movement in the pool thereby causing the pool to be closed, you will be assessed a \$300 fee. Your child may not participate until this fee is paid.

\_\_\_\_\_ **Seating for Parents and Siblings:** Parents and siblings of swim lessons students may not sit or stand around the teaching pool. Please ask the facility Site Director for direction to the appropriate seating area. The last five minutes of class and the last class of the session you may sit and watch the progress of your child.

**Release and Indemnification:** *For and in consideration of the benefits to me from the use by me and/or my child(ren) of the facilities of Dynamo Parents Club, Inc. (Dynamo Swim Center) and other good and valuable consideration, the undersigned, individually and of his/her heirs and personal representatives, hereby release Dynamo Parents Club, Inc, directors, officers, agents, swim team members, and employees from any and all claims of any kind or nature whatsoever arising out of the use by me and/or my child(ren) of said facilities. The undersigned, individually and for his/her heirs and personal representatives, further agree to indemnify, defend and forever hold harmless Dynamo Parent's Club, Inc. and their directors, officers, agents, swim team members and employees from any and all liability or loss whatever, (including any cost of defending claims) arising out of said use of facilities.*
